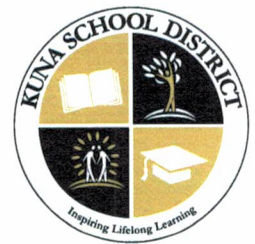

## INDEPENDENT CONTRACT FOR SERVICES

### SY 2021-2022

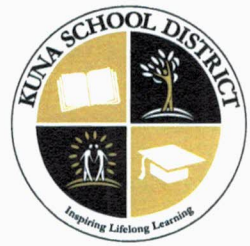
THIS INDEPENDENT CONTRACT FOR SERVICES ("Contract") is made and entered into this 1<sup>st</sup> day of September 2021, by and between **KUNA SCHOOL DISTRICT NO. 3**, Idaho ("District") and **Brent Bowman, Hearing and Communication Technology**, (hereby referred as "Contractor").

The Parties agree as follows:

1. **CONTRACTOR:** Contractor is a qualified audiologist licensed by the State of Idaho and is by definition a practitioner of the healing arts and is qualified to determine covered services that are medically necessary for Medicaid reimbursement.
2. **RESPONSIBILITIES OF CONTRACTOR:** Audiology screenings during preschool screener days when requested (**August 26-27, 2021, October 20, 2021, and February 2, 2022**) and calibration of audiometers.
3. **INDEPENDENT CONTRACTOR:** Contractor is an independent contractor, and no employee, employer or agency relationship is created by this Contract. The Contractor shall be responsible for the payment of all taxes or other required tax withholding or reporting requirements and responsible for all employee benefits, either as required by state or federal government, and the District shall not in any way be responsible for the same. The Contractor will also provide the District with proof of liability insurance prior to the first required payment.
4. **CONTRACT FEES:** District will pay Contractor based upon \$50 hourly rate for 8 hours a day, for four days of screening dates (as requested): no more than \$1600. The District reserves the right to periodically review all approvals and/or disapproval given by Contractor and to monitor the frequency of Contractor approvals and to have the authority to reduce or balance the number of approvals to provide fairness to all eligible students.
5. **NON-ASSIGNMENT:** Contractor may not assign any interest in this Contract for any purpose, and any assignment would be considered an immediate breach of this Contract.
6. **Termination:** This is an agreement for one year. It is expected that Contractor will fully perform the required services for the duration of this Contract, which will terminate on the 2nd day of June, 2022; provided, however, District reserves the right to terminate or modify this Contract, with or without cause, by giving Contractor thirty (30) days' notice of either modification or termination and the effective date of either.
7. **RECORDS/DOCUMENTS:** All records or documents prepared, modified or received as generated by this Contract shall be and remain the property of the District.
8. **CONFIDENTIALITY:** Contractor agrees to maintain all information from services provided by Contractor in absolute confidence, and Contractor fully understands the need for such confidentiality when dealing with student records of any kind.


